1.1 supervisor / supervisor

A supervisor is a skilled and experienced person who supervises a junior social worker in the organisation in terms of knowledge and skills in the profession. This person also provides support to the juniour social worker and guides the worker in terms of quality serive delivery

1.2 administration / administrasie

Asministration is a continuous process of filing, recording and keeping up to date with organisation information as well as client files. Administration is not just a phase on its own, it involves everything within the organisation.

1.3 evaluation / evaluering

Evaluation is a form of monitoring progress, in order for evaluation to take place, one would need to set goals and objectives and targets in which one would like to achieve.
